\* A thesis or a final project is required of all candidates for the Master of Music in Teaching and Learning. During the first year of the MM, candidates should discuss their options with the Department Chair. The thesis will consist of a research document written on a topic approved by the Music Teaching and Learning department; the final project will consist of a creative project that will present the arrangement, production or design of innovative ideas, materials or curricula for specific applications in teaching music. Before registering for 594a Thesis or 590 and 592 (for the project option), a student must establish a guidance committee composed of three members of the faculty, approved by the department chair, of which at least two are from the home department. The chair of the guidance committee directly supervises the preparation of the thesis, the final acceptance of which is based upon the unanimous recommendation of all three members of the committee. If a student does not complete the thesis in two semesters, they will be required to continue to register for MTAL 594Z every semester until completion. This course gives 0 units of credit but is charged at the rate of 2 units of tuition. Thus, delay can be expensive.

If a student does not pass the entrance exams in these areas, they must take the appropriate review courses during the first two semesters of the program. As these courses are at the 300 level (e.g., MUCO 333), they are not considered graduate courses and cannot be used to fulfill elective credit toward the M.M. Therefore, they will add units to the total number of units you will need to take to complete your degree. Students who hold a Bachelor of Music or a Bachelor of Arts degree from the Thornton School of Music are exempt from any examinations in fields in which they have taken comparable coursework. The degree is set up so that a student can earn the M.M. in 4 semesters at 8 units each semester, for a total of 32 units. Because the degree only requires 30 units, this allows for 2 units of review courses to be taken within these 4 full-time semesters. If a student passes all of the required entrance exams, they may obtain the degree with only 30 units, and will not be required to be at 8 units all four semesters. If, however, a student has to take more than 2 units of review courses, they will need to register for more than 8 units during one or more of the four semesters.
