Information for Certification:

California has a two-tier credential structure. A five-year preliminary credential is the first credential issued after an individual meets basic credential requirements. A clear credential is issued when all credential requirements have been completed. Upon successful completion of the MM, CTP degree, candidates are recommended for a preliminary credential. Internships and induction programs that lead to clear credentials are currently satisfied under the purview of your district of employment.

Preliminary teaching credential candidates must meet the following requirements in order to be recommended/endorsed for a teaching credential: Basic Skills Competency (CBEST), Subject Matter Competency (CSET), successful completion of all MM, CTP course work, passing the US Constitution exam, verification of training in cardiopulmonary resuscitation (CPR) that covers infant, child and adult CPR skills, and evidence of successful completion and passing of the edTPA (Teaching Performance Assessment and Portfolio).

If a student does not pass the entrance exams in these areas, s/he must take the appropriate review courses during the first two semesters of the program. As these courses are at the 300 level (e.g., MUCO 333), they are not considered graduate courses and cannot be used to fulfill elective credit toward the MM degree. Therefore, they will add units to the total number of units you will need to take to complete your degree. Graduate students who have previously completed a degree at USC Thornton are exempt from any exam covering a subject area in which they previously completed coursework at USC Thornton or previously passed a MGEE at USC Thornton.
